

STIPULATED CREDIT TERMS

Unless other credit/deposit terms apply to the particular End-user:

- 1) Subscription charges are invoiced quarterly and all transaction charges are invoiced monthly. All sums are to be paid within 28 days of invoice date.
- 2) Sums not paid within such time shall carry interest at the rate of 2% per annum above the base lending rate (LIBOR) from the date of invoice to the date of actual payment.
- 3) All sums are net of VAT or other applicable sales tax.
- 4) Where shortened credit or deposit terms apply to the particular end-user, then a right of disconnection without notice shall apply in the event of the End-user failing to honour such terms.
- 5) Payment of all amounts due shall be made by you in full without any deductions whatsoever by direct debit or Direct Bank Payment only.
- 6) We may impose a charge of £15.00 (or such other sum as we may from time to time reasonably determine) to cover our costs in the event that your payment is not honoured by your bank or other financial institutions.
